

AGREEMENT BETWEEN PAULDING EXEMPTED VILLAGE BOARD OF EDUCATION AND PAULDING EDUCATION ASSOCIATION REGARDING COLLECTIVE BARGAINING CONTRACT

This Agreement is entered into by and between the Paulding Exempted Village School District Board of Education and the Paulding Education Association (collectively, "the parties") as of May 19, 2011, the date by which it was ratified by both parties. The parties agree as follows:

1. The Paulding Exempted Village School District Board of Education and the Paulding Education Association (collectively, "the parties") are currently parties to a Collective Bargaining Agreement in effect from July 1, 2009-June 30, 2012. By mutual agreement, the parties hereby rescind and terminate their current collective bargaining agreement, effective May 19, 2011.
2. The parties further agree to enter into a Collective Bargaining Agreement the terms of which are set forth herein and shall take effect May 19, 2011, and shall remain effective through June 30, 2014. It is the intent of the parties that said Collective Bargaining Agreement, having been ratified as of May 19, 2011, shall be deemed a collective bargaining agreement "entered into" prior to any effective date of Sub. Senate Bill 5 and prior to the effective date of House Bill 153 (the budget bill).
3. Except as expressly set forth below, the Collective Bargaining Agreement ("Contract") terms, conditions, and language that shall go into effect on May 19, 2011, shall be the same as set forth in the current Collective Bargaining Agreement, including, but not limited to, all of the parties' Memoranda of Understanding.
4. In the 2012-2013 and the 2013-2014 Contract years, the parties will negotiate wages only.
