**AGREEMENT TO REQUEST FACTFINDING PANEL;
TO EQUALLY SPLIT COSTS OF FACTFINDING;
TO EXTEND FACTFINDING TIMELINES;
TO CONTINUE TERMS OF THE CURRENT COLLECTIVE
BARGAINING AGREEMENT; AND TO PROVIDE
FOR RETROACTIVITY OF CERTAIN ECONOMIC ITEMS**

The parties hereto, the Fraternal Order of Police, Capital City Lodge No. 9 and the City of Pickerington, hereby agree:

- (1) That they hereby request that the State Employment Relations Board ("SERB") provide them with a fact-finding panel from which they will select a single factfinder for appointment by SERB as factfinder herein.
- (2) That they will equally share the fees and expenses of the factfinder.
- (3) To extend the timelines of the statutory fact-finding procedure pursuant to O.A.C. 4117-9-05(G), such that the period of time for conduct of the factfinding evidentiary hearing is extended until January 31, 2013.
- (4) To continue in full force and effect the terms of the parties' current collective bargaining agreement until a successor collective bargaining agreement is reached or implemented whether as a result of ratification of a tentative agreement or through the use of the statutory dispute resolution procedure.
- (5) Unless the parties agree otherwise, that any wage increases or other matters with cost implication for bargaining units' members shall be effective January 1, 2013, and retroactive to such date, if necessary, notwithstanding the provisions of R.C. 4117.14 (G)(11), or any other provision of law which might suggest a later effective date.


(6) This Agreement will expire January 31, 2013 unless extended by agreement of the parties, in writing.


