This Memorandum of Understanding is entered into by and between the Monroeville Local School District Board of Education and the Monroeville Teachers' Association and is intended to modify certain provisions of the Negotiated Agreement between the parties. This Memorandum of Understanding is effective August 1, 2013 and will be included in successor negotiated agreements unless changed by mutual agreement of the parties.

- 1) This agreement endorses Board Policy 4.04, adopted June 24, 2013, as the teacher evaluation procedure for the Monroeville Local Schools, replacing Article IV, Section E, for all teachers required by law to be evaluated under the Ohio Teacher Evaluation System ("OTES"). This agreement eliminates the teacher evaluation instrument in Appendix A of the Negotiated Contract for all teachers required by law to be evaluated under OTES. Further, the date in Article IV(A)(3) of March 15 for the Board meeting, shall be replaced with the regularly scheduled May board meeting.
- 2) The MTA acknowledges that it was consulted, as required by law, and gave input on the new teacher evaluation system to representatives of the Board of Education.


