AN EMERGENCY ORDINANCE AUTHORIZING THE
EXTENSION OF THE LABOR AGREEMENT BETWEEN THE
CITY OF GARFIELD HEIGHTS AND THE GARFIELD
HEIGHTS FIRE FIGHTERS LOCAL 340 OF THE
INTERNATIONAL ASSOCIATION OF FIREFIGHTERS.

Whereas, the Parties have agreed to extend the term of the current Collective Bargaining Agreement, originally approved by Council on May 9, 2011 pursuant to Ordinance No. 22-2011, for a period of two (2) calendar years expiring on December 31, 2014.

Now Therefore, be it ordained by this Council of the City of Garfield Heights, Ohio that:

Section 1. The Mayor is hereby authorized and directed to extend the Collective Bargaining Agreement between The Garfield Heights Fire Fighters Local 340 of the International Association of Fire Fighters, for two (2) calendar years expiring on December 31, 2014. A copy of said Extension is attached hereto and expressly made a part by reference and marked, "Exhibit A". *

Section 2. Council declares this Ordinance to be an emergency measure necessary for the preservation of the public health, safety and welfare; therefore, this Ordinance shall be in full force and effect immediately upon the adoption by Council and approval by the Mayor; otherwise from and after the earliest period allowed by law.

**EXTENSION OF COLLECTIVE BARGAINING AGREEMENT
CITY OF GARFIELD HEIGHTS AND GARFIELD HEIGHTS, LOCAL 340 IAFF**

The City of Garfield Heights, Ohio and the Garfield Heights Firefighters, Local 340, International Association of Fire Fighters, enter into this Agreement regarding an extension of the current Collective Bargaining Agreement in effect which expires on December 31, 2012.

The Parties agree:

1. The Parties agree to extend the term of the current Collective Bargaining Agreement, originally approved by the Garfield Heights City Council on May 9, 2011 pursuant to Ordinance 22-2011, for a period of two calendar years, for the years 2013 and 2014 which will then expire on December 31, 2014.
2. By entering into this Extension Agreement the Parties understand and agree that the same terms and conditions as set forth in the current Contract will be extended to and including December 31, 2014.
3. The Parties will abide by the provision of the Ohio Revised Code regarding the commencement of negotiations prior to the expiration of the Collective Bargaining Agreement as extended to December 31, 2014.
4. The Parties agree and acknowledge that by entering into this Agreement each has met their obligation to meet and negotiate in good faith under the provisions of Chapter 4117 of the Ohio Revised Code.




