Pursuant to Section 2.1 of the Collective Bargaining Contract between the Office of the Knox County Sheriff and the FOP/Ohio Labor Council, Inc., dated January 1, 2012 – December 31, 2014, all full-time Deputies Case# 99-REP-09-0198, all full-time Sergeants Case# 99-REP-09-0197, all full-time Lieutenants Case# 01-REP-12-0296 agree to the following:

As of January 1, 2013 the parties agree that in Article 15.5. The payment of unused Comp time shall be paid out twice a year, May 1 and November 1 in each members payroll check.

The parties also agree that in Article 49.2. The longevity payments shall be paid in the members regular payroll check on the first pay period following the members anniversary date.

The Provisions of this MOU shall expire December 31, 2014.
