

**MEMORANDUM OF UNDERSTANDING**

This Memorandum of Understanding ("MOU") is between the Lake Local Board of Education (the "Board") and the Lake Education Association, OEA/NEA, (the "Association") effective as of this 18th day of September 2013.

**It is the agreement of the parties as follows:**


1. The National Honor Society and Helping Hands combined into one paid position titled National Honor Society/Students In Action on the extra and co-curricular schedule. Position will be paid \$1,782.
2. Lake Local Professional Development Committee (LLPDC) to be raised from 0.030 to 0.035 (from \$972 to \$1,134) on the salary schedule.
3. The following positions will be removed from the salary schedule:
  - a. Hockey (\$4,697)
  - b. Tennis Boys (\$3,239)
  - c. Tennis Girls (\$3,239)
  - d. Assistant Hockey (\$2,267)
  - e. Bowling (\$1,943)
  - f. Elementary Band (\$1,943)
  - g. HS Pep Club (\$1,782)
  - h. JV Girls Tennis (\$1,782)
  - i. JH Pep Club (\$972)
  - j. Varsity Club (\$972)


The Board and the Association agree that this MOU shall not establish any precedent or affect any other matter between the Board and the Association;


