**ADDENDUM TO AGREEMENT  
Reopener on Wages March 2014**

This Addendum is entered into this \_\_\_\_\_ day of March, 2014, between and among the Clermont County Commissioners (the "Commissioners"), the Clermont County Sheriff (the "Sheriff"), and the Clermont County Deputy Sheriff's Association (the "Union").

**WHEREAS**, the Commissioners, the Sheriff, and the Union are parties to a collective bargaining agreement effective January 1, 2012, relating to wages terms and conditions of employment for certain employees of the Clermont County Sheriff Department; and

**WHEREAS**, pursuant to that agreement, the Union and the Sheriff reopened negotiations with respect to wages for 2014 for the Sheriff's Supervisors and reached a tentative agreement regarding Article 14 relating to wages; and

**WHEREAS**, the Union has duly ratified the tentative agreement on Articles 14 between the Union and the Sheriff; and

**WHEREAS**, the Commissioners have duly approved the tentative agreement on Article 14 between the Union and the Sheriff.

**NOW, THEREFOR**, in consideration of the above, Article 14 of the collective bargaining agreement is revised to read in the entirety as follows.

**Article 14**

Section 14.1

A. Retroactive to January 1, 2014, the wage rate of a Sergeant shall be sixteen percent (16%) above the top rate of the road deputy.


B. Retroactive to January 1, 2014, the wage rate of a Corporal shall be nine percent (9%) above the top rate of the road deputy.

	Effective 1/1/14
HOURLY	\$33.55
OVERTIME	\$50.33
BI-WEEKLY	\$2,684
ANNUAL	\$69,784

The remaining portions of the parties' collective bargaining agreement effective January 1, 2012, remain unchanged.




