**A RESOLUTION APPROVING COLLECTIVE BARGAINING AGREEMENT
BETWEEN THE MADISON EDUCATION ASSOCIATION AND THE BOARD OF
EDUCATION OF THE MADISON LOCAL SCHOOL DISTRICT**

WHEREAS, the Madison Local School District Board of Education and the Madison Education Association are operating under a collective bargaining agreement effective July 1, 2013 through June 30, 2016 regarding the employment of teachers at the Madison Local School District; and

WHEREAS, the current collective bargaining agreement provides for a reopener in the third year of the contract, which is the 2015-2016 school year; and

WHEREAS, the bargaining teams of the Madison Local School District and the Madison Education Association negotiated a tentative agreement regarding the third year of the collective bargaining agreement.

NOW, THEREFORE, BE IT RESOLVED, that the Board of Education, pursuant to Ohio Rev. Code § 4117.10 and Ohio Rev. Code § 3313.17, approves the collective bargaining agreement, attached to this Resolution as Exhibit A, effective July 1, 2015.

BE IT FURTHER RESOLVED, that the Board of Education hereby authorizes the President of the Board of Education and the Treasurer to sign and execute the collective bargaining agreement on behalf of the Board of Education.
