

CONTRACT ADDENDUM

This Contract Addendum made and entered into on the 30th day of November, 2015, by and between the City of Middletown and the Fraternal Order of Police/Ohio Labor Council, as representative of the Dispatchers unit.


WHEREAS, the City and the FOP/OLC entered into a collective bargaining agreement for the period from January 1, 2014 through December 31, 2016; and

WHEREAS, the collective bargaining agreement contains a wage re-opener provision for the agreement years commencing January 1, 2016 to December 31, 2016 and no other Articles of the Collective Bargaining Agreement were to be considered; and

NOW, THEREFORE, the parties agree that the following amendments to the Agreement:

1. Article 22 – Wages. Section 1 is hereby amended as set forth in Exhibit “A”, attached hereto and incorporated herein. The remainder of Article 22 remains unchanged and is as set forth in the collective bargaining agreement.
2. Members shall participate in the “Performance-Based Compensation” set forth in the Pay & Benefits Ordinance, as adopted by the City Council of Middletown each year. **In 2016, the Performance-Based Compensation is set at \$500.00.**


