**COLLECTIVE BARGAINING AGREEMENT
ADDENDUM NUMBER ONE**

This Addendum Number One made July 24, 2014, by and between Poland Township (hereinafter "EMPLOYER") and the Fraternal Order of Police Ohio Labor Council, Inc. (hereinafter "UNION").

WHEREAS, the parties entered into a Collective Bargaining Agreement effective Month, Day, 2014 through Month, Day, Year. *January 1 through Dec. 31, 2016*

WHEREAS, in order to correct a clerical error in the Collective Bargaining Agreement, the parties agree to amend the Collective Bargaining Agreement in the following manner:


1. The following language in the first line of Section 3 of Article 26, entitled COMPENSATION is deleted in its entirety: "Effective as of the first pay period following the ratification of this Agreement,"
2. The following language shall be inserted as the first line of Section 3 of Article 26, entitled COMPENSATION: "Effective January 1, 2014,"


In all other respects, the terms of the Collective Bargaining Agreement are not modified.
