TENTATIVE MEMORANDUM OF UNDERSTANDING FOR THE 2016-2017 SCHOOL YEAR


This memorandum of understanding is entered into by and between the Board of Education of the Perkins Local School District and the Perkins Education Association.


The CBA ending June 30, 2016 shall be extended in its entirety through June 30, 2017 except as set forth below.


- A. The school year referenced in Section 12.03 shall read "2016-2017."
- B. The deadlines referenced in Section 14.01 are extended through the 2016-2017 school year. This item may be reopened for further negotiations if a school levy passes during the 2016-2017 school year.
- C. The deadline referenced in Section 48.01 is extended through June 30, 2017.
- D. The deadline applicable to Section 5.07(B) is extended through June 30, 2017. For the 2016-2017 school year, the District shall not appropriate additional funds, but unused funds from the prior school year shall be carried over for use in the 2016-2017 school year.
- E. Section 13.01(D) shall be amended to add assistant principals and directors of student services to the list of evaluators.
- F. The last sentence of Section 24.06 is deleted and restated as follows: "The District agrees to schedule two full days in the 2016-2017 school year for professional development and on such days the District shall not have students in attendance. On each of these two full days, there would be allocated 50% for time for the teacher to have personal professional development and 50% for time for group sessions for professional development. The allocation of the time between morning and afternoon shall rotate from one such day to the next."
- G. An additional sentence is added to Section 27.01(A) as follows: "The \$2,000.00 limit shall not apply to teachers who are taking such coursework necessary to obtain College Credit Plus certification, in which case such tuition would be paid in full by the district."
- H. The reference to \$75,000 in Section 27.01(C) shall be reduced to \$38,000.00 for the 2016-2017 school year.
- I. An additional sentence shall be added to Section 24.13 as follows: "The district shall be permitted to utilize two of the five collaboration periods, and the building level team shall be permitted to utilize the other three of the five collaboration periods."
