MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (MOU) is entered between the Gallipolis City School Board of Education ("Board") and the Ohio Association of Public Schools AFSCME/OAPSE Local 349 ("Union") to resolve grievances filed by the Union on June 20, 2016. This MOU is intended to address the matters and contract provisions discussed herein and no other issues. The Board and Union agree as follows:

1. Effective July 1, 2016, twelve month secretaries (Doris Henry, Carita Montgomery, Kristine Stout shall have their annual workdays reduced from 261 TO 232.
2. Doris Henry, Carita Montgomery and Kristine Stout shall be allowed to schedule the additional unpaid days at their discretion.
3. The daily hours of all Aides shall be reduced to twenty-nine (29) hours.
4. The Board shall be responsible for paying 62.5% of the Aides' health insurance with the Aides being responsible for paying the remaining 37.5%.
5. This agreement is non-precedent setting and cannot be used by either Party in the future.
