

District Counter Offer

In response to MTA's counter offer of a 3% increase and no step 26 for the 2016-17 school year or a 2% increase with a step 26 for 2016-17. The BOE rejects both counter proposals.

There was discussion by MTA of a onetime bonus to cover additional cost of insurance (5% increase) and 1% increase in employee STRS contribution. The estimated total increase to employees to be on average \$600.

In response to this latest one time bonus discussion the BOE would counter with a one time bonus amount of ~~\$300~~ to each employee to assist in covering additional out of pocket increases for insurance and STRS employee contribution.
