ORDINANCE NO: 2015-225

INTRODUCED BY: Bell

AN ORDINANCE AMENDING ORDINANCE NO. 2015-216 WHICH AUTHORIZED A COLLECTIVE BARGAINING AGREEMENT WITH THE SOLON FIREFIGHTER'S ASSOCIATION, INTERNATIONAL ASSOCIATION OF FIREFIGHTERS, LOCAL 2079, TO CORRECT THE TIMEFRAME FOR THE AGREEMENT, AND DECLARING AN EMERGENCY

WHEREAS, on October 19, 2015, the Council approved Ordinance No. 2015-216 authorizing the Mayor to enter into a Collective Bargaining agreement with the Solon Firefighter's Association, International Association of Firefighters, Local 2079; and

WHEREAS, due to a clerical error, the ordinance incorrectly indicated the agreement is effective for the period January 1, 2016 through December 31, 2019; and


WHEREAS, the ordinance should state the effective period of the agreement is January 1, 2016 through December 31, 2018.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Solon, State of Ohio:


SECTION 1. That Ordinance No. 2015-216 is hereby amended to indicate the Collective Bargaining Agreement with the Solon Firefighter's Association, International Association of Firefighters, Local 2079, is effective for the period beginning January 1, 2016 through December 31, 2018, as indicated in Exhibit "A" of the agreement attached to Ordinance No. 2015-216.

SECTION 2. This Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public health, safety and welfare and for the further reason that it is immediately necessary to indicate the correct three-year period of the agreement with the Firefighters; wherefore, provided this Ordinance receives the affirmative vote of two-thirds of the members of Council elected or appointed, it shall take effect immediately upon its passage and execution by the Mayor; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.


AN ORDINANCE AUTHORIZING THE MAYOR  
TO ENTER INTO A COLLECTIVE BARGAINING AGREEMENT  
WITH THE SOLON FIREFIGHTER'S ASSOCIATION,  
INTERNATIONAL ASSOCIATION OF FIREFIGHTERS, LOCAL 2079,  
AND DECLARING AN EMERGENCY

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Solon, State  
of Ohio:

SECTION 1. That the Mayor be, and she hereby is, authorized and directed  
to enter into an agreement with the Solon Firefighter's Association, International Association  
of Firefighters, Local 2079, for the period beginning January 1, 2016 through December 31,  
2019, a copy of which agreement is attached hereto as Exhibit "A" and incorporated herein  
fully as if by reference.

SECTION 2. This Ordinance is hereby declared to be an emergency measure  
necessary for the immediate preservation of the public health, safety and welfare and for  
the further reason that it is immediately necessary to approve the agreement with the  
Firefighters; wherefore, provided this Ordinance receives the affirmative vote of two-thirds  
of the members of Council elected or appointed, it shall take effect immediately upon its  
passage and execution by the Mayor; otherwise, it shall take effect and be in force from and  
after the earliest period allowed by law.
