**SUPPLEMENTAL AGREEMENT BETWEEN THE DEFIANCE COUNTY SHERIFF AND DEFIANCE COUNTY
SHERIFF DEPUTIES ASSOCIATION**

This document will serve as a one year extension of the agreement between the Defiance County Sheriff and the Defiance County Sheriff Deputies Association dated March 1, 2008 through March 1, 2011, and extended through the calendar years of 2011, 2012, and 2013. This agreement will begin January 1, 2014 and will end on December 31, 2014. All provisions of the initial agreement will remain in force, and the additional provisions agreed upon will also remain in effect. The additional provisions not listed in the initial agreement are listed below:

1. The summer uniform change will take place on the first Saturday in April, and the change to winter uniforms will take place on the first Saturday in November.
2. The rate for all projects is \$20.00 per hour.
3. All time worked during fair week at the Defiance County Fair, with the exception of actual on-duty time, will be compensated on a hour for hour basis. (Comp. Time)

Also included with the supplemental agreement is the recognition of the county wide pay increases for the calendar years of 2011, 2012, and 2013, and, if applicable, any county wide pay increase for the calendar year of 2014. Furthermore, all junior officers currently on wage scale steps, will continue to receive their yearly increment.
