	:	<u>Fact-Finder's Findings, Recommendations</u>

On February 7, 2011, the Ohio Patrolmen's Benevolent Association and the City of Bryan met for a fact-finding hearing in front of Fact Finder Burt W. Griffin. The remaining unresolved issue between the Union and the Employer was wages.


The Fact Finder has recommended and the parties have accepted the following tentative agreement for the respective collective bargaining agreements between the parties which are hereby entered as the findings, recommendations, and report of the fact-finder pursuant to Section 4117-9-05(L) of the Ohio Administrative Code and Section 4117.14 of the Ohio Revised Code.

Article 31 (Patrol/Detectives) – Compensation and Article 29 (Sergeants) – Compensation of the respective collective bargaining agreements shall be amended as follows: effective January 1, 2011 all covered employees shall receive a 1.95% increase in their hourly rate; effective January 1, 2012 all covered employees shall receive a 1.95% increase in their hourly rate; and effective January 1, 2013 all covered employees shall receive a 1.5% increase in their hourly rate.

Further, the Fact Finder recommends and the parties have accepted the suggestion to reduce the time frame it takes to reach top pay from sixteen (16) years down to fifteen (15) years for both collective bargaining agreements. Therefore Article 31 (Patrol/Detectives) and Article 29 (Sergeants) shall be amended accordingly so that the pay matrix is compressed from top pay reached at sixteen years to fifteen years. No other language of Article 31 (Patrol/Detectives) and Article 29 (Sergeants) have been changed.


Finally, the duration of the collective bargaining agreements, Article 36 (Patrol/Detectives) and Article 33 (Sergeants), shall be amended to state from October 29, 2010 until October 18, 2013.

Therefore, it is the recommendation of this Fact Finder that the above-detailed mediated settlement shall be incorporated as the final report which shall be subject to the three-fifths voting standards of the statute.


